EBNMP -NA is the only authorized organization accredited by the American Naturopathic Association. Please also note that several members of the American Naturopathic Association are co-founders of WONMP. (see enclosed)

EBNMP -NA under the leadership of Dr. McKenzie-Barnswell- Public Health Diplomat under International Parliament for Safety & Peace, was granted accreditation as a Sub Group under the World Organization of Natural Medicine Practitioners Humanitarian Medicine Programs.

CLINICS FOR HUMANITY:

The mission of WONMP is to fulfill the duty entrusted to it by the World Government of World Citizens, the Sovereign Orthodox Order of Knights Hospitaller and by its accreditation under the IPSP --- namely, the delivery of primary health care and natural medicine to the worlds economically deprived peoples. The human cost of neglect and conflicts are immense, and the physical and psychological wounds they inflict on the population are enormous. The latter heal very slowly. The Children and elderly become malnourished and the people so inflected heal very slowly this reinforces the necessity of developing a worldwide group, geared to education, health and peace. Hopefully, this will awaken within societies, the values, attitudes and bonds of common interest necessary to transcend the differences arising from conflicts and inequities.

Governments are restricted in providing cost effective primary health care to the poor, due to their reliance on manufactured drugs. DESIGNATION AND DEGREE WHAT THE DIFFERENCE??

A designation under the EBNMP-NA or any other board is not a degree, to become a doctor or a practitioner of Natural Medicine or any other Medical system you must first obtain an undergraduate degree in basic medical sciences then attend a Natural Medicine school for 4000 hours (approximately 4 years doctors' level). And 2000 hours (undergraduate program) practitioners level. The registrant must take and pass board certification examinations to then receive a designation. A designation provides proof that the recipient has met the in educational standards of an accrediting organization for receiving and affixing such designations to his/her name.

OPEN LETTER FROM THE OPEN INTERNATIONAL UNIVERSITY OF COMPLIMENTARY MEDICINE

Medicina Alternativa and the Open International University for Complimentary Medicines.

Many people claim that they are the inheritors of the legal status to both these institutions.

A) Medicina Alternativa is a registered legal Trust No.432 where the Deed of Trust incorporates the registered Medicina Alternativa. Any claim or violation or use of the registered name of the Trust without the sanction, approval of the Trustees can be subjected to legal action.

B) The Open International University for Complementary Medicines charter was granted on August 10th, 1962 and 1975. It is a part and parcel of the Medicina Alternativa Trust. Since, 1975 teaching and certification has been conducted. The University Grant Commission has acknowledged the functioning parameters of both these institutions.

Any attempt by any person to use the Trade marks/Trade Name (Logos) of both the said legally formed institutions will constitute a violation of the proprietary rights and would be an unlawful act in terms of the provisions of the intellectual Property Act No. 36 of 2003 to which Sri Lanka is a signatory.

It is unfortunate that a number of ambitious persons claims all sorts of credentials are trying to organize Congresses for their own benefit.

It is of interest to publicize a section of the constitution of Medicina Alternativa and the Open International University for Complementary Medicines.

Section Z page 3 outlines that all appointments are in force only for a period of three years whether explicitly stated or not, affiliations will terminate or lapse on the departure of the Dean of Clinical Studies/Chancellor/Chairman, or for cause.

All appointments which do not carry remuneration or monetary compensation falls under section Z of the constitution. The appointments so specified are Vice Chancellors/Hon. Faculty Members.

ACCREDITATION, REGULATION & ASSOCIATION

What is the difference between the terms accreditation, Regulation

Accreditation is to certify (a school, college or individuals, or the like) as meeting all formal official requirements of academic excellence, curriculum, facilities, etc.

The Examining Board of Natural Medicine Practitioners -North America is an Accreditation Organization and Registry for Doctors and Practitioners of Natural Medicine, who have met the standards of Natural Medicine Education as established by the World Organization of Natural Medicine (WONMP)

Regulation is a law, rule or other order prescribed by authority, esp. to regulate conduct, the act of regulating or the state of being regulated.

Regulation can only be imposed by government authority (Federal, Provincial or State)

Association is an Organization of people with a common purpose and having a formal structure. Association is self direct and answerable to its members EBNMP-NA

Section 1 subsection (9) “Propagation of Natural Medicine Practices by helping and supporting and establishing provincial (Canada) and State (USA) Natural Medicine Association”.

ASSOCIATIONS

Please be advised that, Professional Associations being answerable to its members are completely autonomous to EBNMP-NA or any other board. Associations are not required to provide any financial statements or any reporting to any organization except its members. Members in such associations must meet an accreditation to use the DNM or RNP designations.

MEMBERSHIP DUES

All registration or renewal fees must be made payable directly to EBNMP-NA in the form of a cheque or money order. Any payment made payable to any director or directors company is unauthorized and constitute professional misconduct.

As per EBNMP-NA by law, members shall receive financial statements of its operation in a written format and at the end of each fiscal year.
